You are eligible to join the Scheme if you are engaged to perform cleaning work in the contract cleaning industry in Queensland to:

- clean premises: or
- clean premises and supervise other workers in the contract cleaning industry.

DEFINITIONS

Contract cleaning industry

The industry in which individuals are engaged to perform cleaning work for other people.

Cleaning work

Work that has, as its main or only function, the bringing of premises into, or keeping of premises in a clean condition.

Premises

- Includes houses and buildings
- Excludes planes, trains, boats, vehicles, swimming pools, and grounds surrounding a building, house or swimming pool.

WHAT HAPPENS AFTER YOU COMPLETE AND LODGE THIS APPLICATION?

- Your application will be processed by the Authority and if you are eligible for registration you will receive a membership number.
- Your membership number should be given to each new employer to ensure your long service leave entitlement grows.
- A long service leave statement detailing your portable long service leave credits will be made available to you each year.
